- Approved Q3 finance report, which was then posted on the branch website.

- Held a member "Meet and Greet" on Zoom, April 8, 3:00pm

May

- Distributed May Onliner News to members.
- Held a member "Meet and Greet" on Zoom on May 12, 3:00pm
- Held a board meeting on May 24 at 7:30 via Zoom to introduce newly elected board, to adopt Policies and Procedures revisions, and to review our branch 5-Star submission, (see separate minutes for that meeting)
- Authorized donation of \$140 to the Greatest Needs Fund in honor of AAUW's 140th anniversary
- Approved minutes of Zoom board meeting, which were then posted on the branch website
- Held a Zoom program meeting with a firsthand report from the war in Ukraine.

- Discussed the challenges in monitoring renewals and access for all members to a membership roster with the new AAUW Community Hub replacing the Member Service Database (MSD).
